- All minutes of Governing Body of the College should be submitted to the office of the Bihar Engineering University, Patna at the earliest.
- When any vacant posts will be filled by the College, University representation should be invited. Any appointments must be done in the presence of University Representative.
- College is requested to approve and appoint all teaching & non-teaching employees as per guidelines of the AICTE in three months.
- The provisional affiliation has been granted in anticipation of approval of the Executive Council, Bihar Engineering University, Patna.
- Failing the above terms & conditions, this letter will be automatically treated as withdrawn. In such a case no further correspondence shall be entertained.
